THE OPERATION TODAY

Snowy Hydro Limited owns and operates the 3800 megawatt (MW) Snowy Mountains Hydro-electric Scheme, and the 300MW Valley Power and 320MW Laverton North gas fired power stations both located in Victoria. In addition, we are the parent company of Red Energy, an electricity retailer selling electricity and gas direct to consumers.

Snowy Hydro is a leading supplier of electricity price risk hedging contracts to other National Electricity Market (NEM) participants (retailers and other generators) who are seeking protection to limit the price risk they face in the volatile NEM.

Snowy Hydro's ability to draw on large scale generation at short notice means that it is able to offer such contracts, and generally hedge the risk it takes on those contracts by generating electricity as required.

Snowy Hydro is one of the National Electricity Markets largest generators by capacity. Our portfolio of Snowy Mountains Scheme hydro generation assets and Victorian based gas-fired capacity places us in a strong position to take advantage of periods of high prices in the NEM.



OVER 750 STRONG

Snowy Hydro's business is based across New South Wales and Victoria, and currently employs over 750 people in Sydney, Cooma, Jindabyne, Khancoban, Cabramurra, Talbingo, Melbourne and Traralgon. Around 170 of these employees are located in Cooma, over 320 in Victoria and the rest spread across the townships of the Snowy Mountains region and Sydney.

> The Company

Snowy Hydro Limited was formed in 2002, when the electricity trading business, Snowy Hydro Trading Pty Ltd was combined with the corporatised Snowy Mountains Scheme asset business, Snowy Mountains Hydro-electric Authority.

Snowy Hydro Limited operates in the highly competitive National Electricity Market, which was formed in 1998, following the process of deregulation of the Australian power industry by the State and Commonwealth Governments.

Since corporatisation in 2002, Snowy Hydro Limited has grown the business, consistently returning above average financial returns to our shareholders.

> Essential water

Snowy Hydro also provides essential water to in-land irrigators and water for environmental releases. Under normal water inflow conditions, a total of 2088 gigalitres are released into two state owned holding dams, Blowering Reservoir and the Hume Reservoir, in accordance with the Snowy Water Licence. Both reservoirs are controlled by government authorities for release to irrigators.

A powerful combination of hydro and gas-fired electricity generation

Snowy Hydro Limited owns and operates the Snowy Mountains Hydro-electric Scheme, a network of seven major power stations, 31 generating units, 16 dams and 225 kilometres of tunnels and aqueducts dispersed over a catchment area of 5124 square kilometres in the Kosciuszko National Park.

Snowy Hydro also owns and operates two gas-fired power stations in Victoria, one in the Latrobe Valley and the other in Laverton North on the outskirts of Melbourne's CBD. The combined total of 620MW from the

two gas-fired stations complement our hydro-electric assets, enhance our ability to generate at times of peak demand in Victoria, and hedge exposure arising under electricity price risk hedging contracts.

The Snowy Mountains Scheme and the gas-fired power stations form the asset portfolio of the overall business, which takes the generation capacity of Snowy Hydro Limited to over 4400MW and makes us the third largest generator by capacity in the National Electricity Market.

Red EnergyOur Electricity Retailer



Snowy Hydro acquired Red Energy, a Victorian based electricity retailer, in November 2004. Its retail electricity and gas customer base is currently around 250,000 and growing. Red Energy operates in Victoria, South Australia and New South Wales.

As Red Energy looks towards the future, we want to make sure the customer experience continues to reflect who we are and what we stand for. Most importantly, we recognise that the Red brand isn't something owned by marketing alone.
