SNOWY HYDRO'S "SCIENCE OF THE SNOWY SCHEME" COMPETITION TERMS AND CONDITIONS

1. COMPETITION AND PROMOTER'S DETAILS

- (1) Information on how to enter and prizes forms part of these Terms and Conditions. Entry Snowy Hydro's "Science of the Snowy Scheme" Competition (Competition) is acceptance to these Terms and Conditions.
- (2) The Competition commences at 8.00am AEST on Monday, 14 August 2017 and closes at 5pm AEST on Friday, 22 September 2017 (Competition Period).
- (3) The Competition is a game of skill.
- (4) The promoter is Snowy Hydro Limited ABN 17 090 574 431 of Monaro Highway, Cooma NSW 2630 (Promoter).

2. ELIGIBILITY

- (1) Entry is open to school students enrolled in years 3-6 in all the schools in the Snowy Valleys Council or Snowy Monaro Regional Council regions. (**Eligible Entrant**).
- (2) Entrants under 18 years must have parental or legal guardian approval to enter the Competition and further, the parent(s) or legal guardian(s) of the Entrant must read and consent to these Terms and Conditions. - (g) the name of the Eligible Entrant;
- (h) the year and school the Eligible Entrant is enrolled in; and
- (i) the Eligible Entrant's parent(s) or legal guardians contact details (including, address, phone number and email address).
- (2) An Eligible Entrant who submits a valid entry by following the process set out in **clause 4(1)**, will be an "Entrant". Each Eligible Entrant may only submit 1 entry.
- (3) Entries received outside of the Competition Period will be ineligible for entry. Entries are deemed to be received at the time of receipt by the Promoter. Records of the Promoter are final and conclusive as to time of receipt.
- (4) An Entrant must not submit any entry:
