TERMS AND CONDITIONS

1. COMPETITION AND PROMOTER'S DETAILS

- (1) Information on how to enter and prizes forms part of these Terms and Conditions. Entering Snowy Hydro's "Snowy Scheme in pictures" Competition (**Competition**) is acceptance to these Terms and Conditions.
- (2) The Competition commences at 8.00am AEST on Monday, 9 May 2022 and closes at 5:00pm AEST on Sunday 17 July 2022 (**Competition Period**).
- (3) The Competition is a game of skill.
- (4) The promoter is Snowy Hydro Limited ABN 17 090 574 431 of Monaro Highway, Cooma NSW 2630 (Promoter).

2. ELIGIBILITY

- (1) Entry is open to school students enrolled in years 3-6 (stages 2 & 3), years 7-10 (stages 4 & 5) and years 11 & 12 (stage 6) from all schools in the Snowy Mountains and surrounding areas' postcodes specified in the Schedule (**Eligible Entrant**).
- (2) Entrants under 18 years must have parental or legal guardian approval to enter the Competition and further, the parent(s) or legal guardian(s) of the Entrant must read and consent to these Terms and Conditions. The parent(s) or legal guardian(s) may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering the Competition and accepting and participating in the Prize, including agreeing to the releases contained in these Terms and Conditions.
- (3) The Promoter may exclude an entry from the Competition if it reasonably considers that:
 - (a) third party intellectual property rights may exist in that entry (including any photograph posted as part of an entry);
 - (b) the Entrant has not complied with clause 3(6); or
 - (c) the Entrant has otherwise not complied with these Terms and Conditions.

3. HOW TO ENTER

- (1) To enter the Competition, an Eligible Entrant must, during the Competition Period complete and submit an entry to the Competition by submitting a design of their favourite Snowy Hydro Scheme asset. The Entrant may paint, draw or produce a digital design for their artwork entry.
- (2) An eligible entry must:
 - (1) Be clearly identifiable as a Snowy Hydro Scheme asset;
 - (11) Be appropriate for reproduction on a tea-towel and/or postcard;
 - (111) Be scanned using an A4 piece of paper;
 - (1v) Be clear and legible; and
 - (v) Include the Snowy Hydro Scheme asset name, student name and student age when submitting an entry through the online portal (see **clause (3)** below)
- (3) Entries must be submitted to the Promoter through the portal on the Snowy Hydro website at www.snowyhydro.com.au/artcomp
- (4) An Eligible Entrant who submits a valid entry by following the process set out in **clause 3(2)**, will be an "Entrant". Each Eligible Entrant may only submit one (1) entry.
- (5) Entries received outside of the Competition Period will be ineligible for entry. Entries are deemed to

be received at the time of receipt by the Promoter. Records of the Promoter are final and conclusive as to the time of receipt.

- (6) An Entrant must not submit any entry:
 - (a) that contains images of another person without that person's permission (or in the case of a minor, the minor's parent(s) or legal guardian(s) permission);
 - (b) for which a third party holds the intellectual property rights where you have not obtained all necessary consents to copy, disclose, distribute, incorporate or otherwise use the material for any purpose;
 - (c) that is discriminatory, obscene, pornographic, defamatory, liable to incite racial hatred, in breach of confidentiality or privacy, which may cause annoyance or inconvenience to others, which encourages or constitutes conduct that would be deemed a criminal offence, give rise to a civil liability, or otherwise is contrary to the law in Australia; or
 - (d) that may be used in connection with spamming, phishing, trolling or similar activities.

4. THE PRIZES

- (1) The Promoter is offering Entrants the chance to win one (1) of three (3) identical prizes. That is, each winner will win:
 - (a) a trip for the winner's family (up to a maximum of 2 adults and 2 children) to the Snowy Mountains for a behind-the-scenes tour of a Snowy Hydro asset in Spring 2022; and
 - (b) the right to see their creative design reproduced on a piece of Snowy Hydro merchandise,

subject to clause 7 (Prize).

- (2) The Prize is not transferable or exchangeable and cannot be taken as cash. The Prize must be taken as offered and cannot be varied. The Promoter accepts no responsibility for any tax implications that may arise from winning the Prize.
- (3) Dates, venues and schedules may not be under the Promoter's control and are subject to change. The Promoter takes no responsibility for any date, venue or schedule changes (including any changes due to COVID-19).
- (4) Any costs or expenses which are incurred by a Winner in connection with the Prize not listed in clause 4(1) or clause 7 do not form part of the Prize, and are the responsibility of the Winner.

5. HOW TO WIN

- (1) All valid entries shortlisted in accordance with clause 5(2) will be judged by the Promoter based on which Entrants have submitted the most original, creative and appealing design of their favourite Snowy Hydro Scheme asset. The Entrant may paint, draw or produce a digital design for their artwork entry that is appropriate for reproduction, for example on a tea-towel and/or postcard, and be clearly identifiable as a Snowy Hydro Scheme asset.
- (2) The Promoter will shortlist 30 valid entries to be judged by a judging panel in accordance with clause 5(4), at its discretion.
- (3) The Promoter's short-listed entries will be judged between 9:00am AEDT on 18 July 2022 and 5:00pm AEDT on 1 August 2022 by a judging panel who will select three (3) winners to take out a Major Prize (comprising one (1) winner from Stage 2 &3 (years 3-6), one (1) winner from Stage 4 & 5 (years 7 10) and one (1) winner from stage 6 (years 11 & 12). The judging panel will judge the winners based on which Entrants have submitted the most original, creative and appealing piece of art work of a Snowy Scheme asset which is fit for reproduction on a tea-towel and/or a postcard.
- (4) By no later than Monday 1 August 2022 the Promoter will notify the recipients of the Prizes (Winners) by:
 - (a) email, at the email given to the Promoter as part of their entry into this Competition; and
 - (b) publishing the Winners' names on the Promoter's website at: www.snowyhydro.com.au/artcomp
- (5) If a Winner
 - (a) responds before Monday, 15 August 2022, they will have been deemed to have accepted their Prize (Winner's Acceptance); or
 - (b) fails to respond before Monday, 15 August 2022 , their Prize will be deemed unclaimed then the Prize will be forfeited. It is the Winner's responsibility to respond.

- (6) Within a reasonable time after aWinner's Acceptance, the Promoter will contact the Winner directly provide details of the Prize.
