

2023-24 WATER YEAR SNOWY RIVER DAILY RELEASE TARGETS

Updated - 8 Jun 23

Daily release patterns are notified to Snowy Hydro Ltd from the NSW DPE Water in February of the preceding water year.

Note: Daily targets may be updated by NSW DPE Water at any time. All updates will be uploaded to the Snowy Hydro website as they occur.

Days highlighted in yellow include an 8 hour high flow event. This means that for 8 hours on these days, flows from the dam will be significantly higher than the daily target. The peak values for the days highlighted in yellow are shown on the right.

* Note: NSW DPE Water has instructed that only one of the 8 hr peak flows 1 or 5 will occur and only if reservoir levels allow. If no 8 hr peak occurs on one or either day, then the flow on that date will be 5000ML/d
