Glossary**Incident & Non-Compliance Categories (definitions):****1. Statutory Approvals & Project Staging (Statutory Approvals / Staging Delays)**

Definition: Non-compliances relating to the overarching legal approvals and the formal timelines of the project.

2. Project Governance (Governance)

Definition: Issues relating to the overarching management, internal auditing, and administrative compliance of the project.

3. Public Reporting / Incident Reporting & Governance (Incident Reporting)

Definition: Procedural breaches where the project fails to meet its statutory reporting and public transparency obligations.

4. Environmental Management & Incident Response / Pollution Control

Definition: Relates to failures in the handling of environmental incidents and the containment of pollutants.

5. Surface Water

Definition: Incidents involving the unauthorised, unmanaged, or non-compliant release of water into the environment.

6. Analyte Exceedance / Elevated Analytes

Definition: A specific subset of surface water or groundwater incidents where laboratory or field sampling identifies chemical or physical parameters that exceed approved limits.

7. Missing Water sample

Definition: An administrative/monitoring non-compliance where required routine water samples were not collected.

8. Boundary Breach

Definition: An incident where construction activities, ground disturbance, or vehicle movements occur outside the legally approved spatial limits.

9. Biodiversity

Definition: Incidents relating to unauthorised impacts on native flora, fauna, and their habitats.

10. Biosecurity

Definition: Incidents involving the introduction, movement, or spread of weeds, pests, and pathogens.

11. Waste Management

Definition: Incidents and non-compliances concerning the handling, classification, tracking, and disposal of waste.

12. Heritage & Geodiversity Monitoring

Definition: Relates to impacts on, or failures to monitor, cultural and natural heritage items.
